THE USA CARES QUALITY OF LIFE PROGRAM OFFERS SERVICE MEMBERS WHO NEED ASSISTANCE WITH AN UNEXPECTED CAR REPAIR OR HIGHER THAN USUAL UTILITY BILL. IT IS NOT UNUSUAL FOR A NATIONAL GUARDSMAN OR RESERVIST TO TAKE A SIGNIFICANT LOSS OF INCOME WHEN BEING CALLED TO ACTIVE DUTY. ADDITIONALLY, SOME RETURN HOME FROM THEIR TOUR AND MUST FACE THE DAUNTING TASK OF FINDING A NEW JOB AND STILL HAVE BILLS TO PAY. FOR SOME FAMILIES, AN ERROR IN THE PAY SYSTEM OR DELAYS IN PROCESSING HAVE CAUSED THEM TO NOT RECEIVE INCOME, A SITUATION THAT MAY NOT BE CORRECTED FOR WEEKS. THE QUALITY OF LIFE PROGRAM ENSURES THAT THE BASIC NEEDS OF THE FAMILY ARE MET UNTIL THEY ARE ABLE TO PROVIDE FOR THEMSELVES. FUNDING FROM THE QUALITY OF LIFE PROGRAM PROVIDES ASSISTANCE FOR CRITICAL NEEDS SUCH AS: UTILITIES, AUTO PAYMENTS,

4b (Code:) (Expenses \$ 547,767. including grants of \$ 215,693.) (Revenue \$ 0.) THE USA CARES HOUSING ASSISTANCE PROGRAM BEGAN IN 2005 AT THE RECEIPT OF A GRANT FROM THE HOMEOWNERSHIP PRESERVATION FOUNDATION. THE GRANT, TOTALING \$1.2 MILLION HAS ENABLED USA CARES TO SAVE MORE THAN 400 HOMES FROM FORECLOSURE. THE PROGRAM OFFERS BUDGETARY COUNSELING AND A NEGOTIATION OF THE MORTGAGE TO BRING IT CURRENT. AS THE PROGRAM DEVELOPED, USA CARES REALIZED THE NEED TO OFFER SIMILAR ASSISTANCE TO THOSE MILITARY FAMILIES FACING EVICTION FROM RENTAL PROPERTIES. SINCE THE PROGRAM WAS FIRST IMPLEMENTED IN LATE 2006, NEARLY 300 FAMILIES WERE SAVED FROM EVICTION.

OUR PURPLE HEART PROGRAM ENABLED THOSE SERVICE MEMBERS, DOCUMENTED WITH A PURPLE HEART, TO RECEIVE GRANTS BEYOND THE NORMAL GRANT LIMITS. OFTEN TIMES THESE SERVICE MEMBERS AND THEIR FAMILIES FACE ADDITIONAL HARDSHIPS WHILE RECOVERING FROM THE WOUNDS RECEIVED IN COMBAT. SOON AFTER THE PURPLE HEART PROGRAM BEGAN, USA CARES RECOGNIZED THERE WERE INCREASING INCIDENTS OF FINANCIAL CRISES AMONG THOSE WHO HAD SUFFERED FROM TBI OR PTSD. USA CARES DECIDED TO TREAT THESE AFFECTED SERVICE MEMBERS AND THEIR FAMILIES WITH THE SAME SPECIALIZED ATTENTION AS A PURPLE HEART RECIPIENT, CHANGING THE PROGRAM FROM PURPLE HEART TO THE USA CARES WOUNDED WARRIOR PROGRAM.
